GENERAL AGREEMENT ON EDUCATIONAL CO-OPERATION

Whereas SHINSHU HONAN TANKI DAIGAKU, JAPAN (hereinafter called HONAN COLLEGE) and University of Canterbury, New Zealand (hereinafter called UNIVERSITY OF CANTERBURY) are willing to take responsibilities as educational institutions for sound development of the coming generations, and whereas these two institutions wish to promote friendship and understanding for mutual benefit, HONAN COLLEGE and UNIVERSITY OF CANTERBURY came to an agreement for educational collaboration, as set out in the articles mentioned hereunder.

Article I

The purpose of this General Agreement includes the following:

Item 1 Exchanges of teaching and administrative personnel

Item 2 Exchanges of students

Item 3 Performance of any other educational activities that both parties agree

upon from time to time

Article II

In order to carry out the aforementioned activities, each institution will appoint a co-ordinator for mutual consultation on the organization and execution of the agreement. The details thus agreed upon are to be set forth in the form of a MEMORANDUM OF AGREEMENT prepared separately, and based on the items of Article I.

The aforementioned MEMORANDUM will become effective when signed by the representative authorities of both institutions.

Article III

This GENERAL AGREEMENT will become valid on and after the date of the authorized

signature affixed by both parties. This AGREEMENT may be partly amended or revised by

mutual consent of both institutions. Provided that either party does not convey in writing the

intention of terminating this AGREEMENT, it will remain valid with no time limitation.

Provided that either party wishes to terminate the AGREEMENT, the proposing party should

give written notice of intention to terminate of at least one year before the date of the

termination.

Article IV

In any case where a legal problem occurs in connection with the AGREEMENT and/or the

MEMORANDUM OF AGREEMENT mentioned under Article II, Japanese law should be

applied if the place of occurrence is within the limit of Japanese islands, whereas New Zealand

law is applicable if within the limit of New Zealand islands and territories.

As witness to their agreement to the above articles, this GENERAL AGREEMENT is made out

in quadruplicate (Japanese and English version in duplicate each) and duly signed by the

appropriate authorities of HONAN COLLEGE and UNIVERSITY OF CANTERBURY as

follows. After having signed the four copies of the AGREEMENT, both institutions will keep

one set each (a copy each of Japanese version and English version).
